Commercial conditions and payment terms

An invoice is sent to the participant upon receipt of the training agreement. Full payment shall be made at least two weeks before the beginning of the training services. Any delay would lead to the cancellation of the training agreement (see conditions below). Invoices are due totally.

It is the participant's responsibility to ensure a good and stable internet connection when attending the training. This training Agreement shall in all respects be governed by and construed in accordance with the laws of France.
